### **Deposit**

If you placed a \$350.00 on your puppy the remaining balance must be paid in cash at the time of pickup. This deposit signifies intent on behalf of the buyer to follow through with the purchase of a puppy. Jonathan Creek Doodles/Kim Holdren reserves the right to cancel or refuse any transactional any time without providing a reason. If something unforeseen happens to the puppy (death, illness or injury) the buyer will be notified and the deposit will be transferred to another puppy of the buyers choice. No refunds will be giving.

### **Health Guarantee As A Pet Only**

The breeder guarantees that your puppy is in good health at the time of delivery (Excluding: parasites, umbilical hernias, over/under bites, coccidia, giardia or anything we vaccinate against). We also guarantee that if the puppy is found to have a genetic illness/condition within the first year of life the puppy will be replaced (replacement

puppy described below). We do not guarantee hips, knees, elbows or eyes. For the validity of the health guarantee you must have the puppy examined by a license Veterinary within 72 hours of receiving your puppy. This guarantee is nullified if you do not follow through with the Veterinary exam and return a copy of the Vet receipt to me within 7 days. If at any time during the first year, your puppy is found to have a genetic illness/condition by your licensed Veterinary a written report must be submitted to me from your Vet. If the puppy dies due to reported genetic illness/condition you must have met and you have written proof that you that all advice given by the license written proof that all advice given by your Vet has been followed. After all requirements have been met the breeder will replace the puppy. The replacement puppy must be picked out of our next available litter. Jonathan Creek Doodles/Kim Holdren is not responsible for any expenses you may incur including transportation of either puppy, Vet Expenses or any other expenses. The breeder does not guarantee size, color, confirmation, trainability, breed ability or overall temperament of the puppy. The replacement puppy's transportation and all expenses will be assumed by you.

### **Spay/Neuter Agreement**

You are purchasing this puppy as a pet only. All breeding rights have been reserved and the puppy met be altered as soon as your Vet recommends (which is typically by 6 months of age). You understand that the puppy can come into season as early as 6 months of age and can conceive at that time. I also reserve the right to withhold registrations papers until proof that the puppy has been altered has been sent to me. After the puppy has been altered a copy of the Vet receipt must be forwarded to me. After I have received a copy of the receipt your registration paper will be sent to you in the mail. As a responsible pet owner you are ask to take every precaution to make sure that pregnancy does not happen. I am not responsible for any puppies that may result from any breeding of this puppy. Breeding rights are reserved but are available to approved breeders and can be purchase of an additional cost determined by me. If breeding rights are purchased the registration papers will be released as soon as the additional fees are paid in full.

### **Holding Your Puppy**

We do not like to hold puppies once they are ready for their new owner. We will schedule a date and time for you to pick up your puppy when they are 8 weeks old. Puppies are not sold on a trial basis so please be committed to the puppy for it's entire life span. If a situation arises that prevents you from being able to provide a stable and happy home for your puppy we ask that you contact us and we will do our best to place your puppy in a new home but no refund or exchange will be given. There are no other guarantees either written or implied. There will be a \$50.00 fee for any check that is returned. Your signature will certify that you have read this sales agreement and you clearly understand the conditions of the sales agreement and agree to it fully.
